Kevin is looking into some different aspects of lighting to see if that goes away. But if we cannot design a way, we will approach adjoining neighbors to alert them of the issue to see if there is any objection to the lighting we are planning. The second of which we have this twenty-foot-wide planting strip requirement that we do not adhere to. It provides in your ordinance that we must meet that unless we get adjoining property owners to agree. I drafted a letter to send seeking that consent. They are the only two zoning issues.
